Assumption of the Risk and Waiver of Liability Coronavirus/COVID-19

FOR EVENT ENTRY TO BE VALID, THIS SIGNED WAIVER MUST BE COMPLETED BY EACH OWNER AND HANDLER AND INCLUDED WITH THE DOG'S ENTRY.

NOTICE

The novel coronavirus, Coronavirus/COVID-19, has been declared a worldwide pandemic by the World Health Organization. Coronavirus/COVID-19 is extremely contagious and is believed to spread mainly from person-to-person contact. As a result, federal, state, and local governments and federal and state health agencies recommend social distancing and have, in many locations, limited or prohibited the congregation of groups of people. In an effort to reduce the spread of Coronavirus/COVID-19, preventive measures are in place at QCDC, LLC a/k/a Quad City Dog Center, LLC ("QCDC") for all classes and dog trials, including participation as an exhibitor, spectator or volunteer. Notwithstanding the foregoing, QCDC cannot guarantee that those who enter the facility will not be exposed to or become infected with Coronavirus/COVID-19. Further, participating in class or dog trials at QCDC may increase the risk of contracting Coronavirus/ COVID-19.

LIABILITY WAIVER

By signing this Assumption of Risk and Waiver of Liability, I, the undersigned, acknowledge, on my behalf and on behalf of my minor child(ren) who are listed below ("my child(ren)"), the contagious nature of Coronavirus/COVID-19 and voluntarily assumes the risk that my child(ren), my dog(s) and myself may be exposed to or infected by Coronavirus/COVID-19 while at QCDC and that such exposure or infection may result in personal injury, illness, permanent disability, and death. I understand that the risk of becoming exposed to or infected by Coronavirus/COVID-19 at QCDC may result from the actions, omissions, or negligence of myself and others, including, but not limited to, QCDC's board of directors, members, volunteers, agents, or representatives. With full knowledge and appreciation of the risks outlined above, I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury (including, but not limited to, personal injury, disability, and death), illness, damage, loss, claim, liability, or expense, of any kind arising out of or relating to Coronavirus/COVID-19 exposure/infection that I, my child(ren), or my dog(s) may experience or incur in connection with our physical presence at QCDC. On my behalf, and on behalf of my child(ren) listed below, I hereby release, covenant not to sue, discharge, and hold harmless QCDC, its board of directors, members, agents, and representatives; and the Quad City Dog Center, LLC, its members, agents and representatives, of and from any claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto. I agree to defend and indemnify the released parties for any and all claims brought by a third party which arise from my, my child(ren)'s, or my dog(s)' attendance at QCDC. I understand and agree that this release includes any claims based on the actions, omissions, or negligence of QCDC, its directors, members, volunteers, agents, and representatives, whether Coronavirus/COVID-19 exposure/infection occurs before, during, or after being at QCDC.

If QCDC deems it necessary to employ legal counsel to protect its rights under this Assumption of Risk and Waiver of Liability and the court finds in favor of QCDC, I agree to pay all expenses incurred by QCDC in connection with any claim, including, but not limited to, costs and reasonable attorney's fees.
