Note: Overnight envelopes must have the recipient's signature waiver signed or the envelope may be refused or delayed.
No more than six (6) entries are allowed per envelope. The only exception is all dogs within one (1) envelope have the same five (5) digit CPE member ID number.

There is no Refund of Pre-Entries withdrawn after the closing date except: full refund for Bitches in Season and refund minus \$10 for vet verified illness or injury of dog.	
Move ups/downs	September 2, 2024 by 5pm and Day of Show: 1 hour before level runs
Limits	150 runs per day per judge
There will be a warmup area containing boxes with the odors to be used. Competitors are not allowed to bring their own odors or practice boxes. If a Competitor brings in their own odors or practice boxes then this will result in be excused from the trial.	
DAY OF SHOW ENTRIES: 30 minutes before the level runs.
